CONCEPT NOTE

Indigenous peoples are practitioners of unique cultures which have a harmonious connection with the society they live in, their ancestors and the environment around them. Their belief systems, traditional knowledge, cultures, language and ways of life have always been an invaluable resource for all mankind.

But these cultures of the indigenous peoples are in stark contrast with the ones practiced by dominant societies. And it is this cultural difference that has been the root cause of their discrimination and marginalization, where they have been facing extreme conflict and threat, to the point of extinction. They have been disposed of their traditional land and livelihood and their rights have been violated in almost all parts of the world.

Today, the international community has recognised that special measures are necessary to protect the rights of indigenous peoples and respect their distinct way of life. The United Nations commemorates the International Day of the World's Indigenous Peoples on 9 August every year, and this year, the theme is "Leaving no one behind: Indigenous peoples and the call for a new social contract."
